#### **Response:**

The college has a transparent mechanism and grievance redressal system for time-bound and efficient internal examinations and assessments. The internal examination by the exam department is as per the guidelines given by Savitribai Phule University Pune. The internal examinations are conducted by the Examination Committee. The internal examination and its assessment schedule is prepared by the Coordinator of the examination after discussion with Heads of departments and the Principal of the College. The time table of the internal exam and seating arrangements for examination is displayed on the notice board. The question papers of all subjects are prepared by the subject teachers maintaining its secrecy. The evaluation process is immediately carried out by the teachers after the completion of internal Exams. The assessment of internal exam papers are shown in the class to students to avoid any grievances. Skill enhancement courses and extra credit activities in choice based credit system (CBCS) pattern was complemented in college for all programmes as per the rules and regulations of Parent University. Teachers also evaluate internal marks for home assignments "Seminars, projects and presentation by the students. The teachers prepare their subject wise printed mark lists and submit them to the CEO and H.O.D record is verified by the principal and CEO and then finally are submitted by online mode to the university.

Mechanism to deal with internal examination related grievances is transparent time- bound and efficient. The college strictly follows all the guidelines and rules issued by the affiliating university, SPPU, Pune, While conducting university and internal exams semester-end examinations grievances regarding internal assessment are resolved immediately by the respective course Coordinators. If students have any grievances related to the evaluation of university answer papers they are intimated to apply for answer scripts in which the re-evaluated marks can be obtained during the announcement of revaluation results of the same semester. #### **Direct assessment:**

The total Built Up area of new college building premises is 3340.95 Sq.M. The college has 11 classrooms among this two classrooms are ICT enabled and one seminar hall with LAN, WiFi and LCD Projector and 14 laboratories, play ground, Girls and boys common room, Canteen, LAN system for administrative work, parking area and green campus.

The classrooms are well lit with facilities of lightings, fans, blackboard and natural ventilation. The classrooms are of sufficient size accommodate the necessary students strength. There is computer, printer, internet for examination department. Total 13 CCTV cameras have been provided in college premises to maintain discipline, to curb ragging. College has RO water purifier, 50 litres two separate water coolers, three washrooms for ladies and three washrooms for gents at each respective floor . College also has NSS room, IQAC cell and Student Development Office with internet connection, computer and printer facilities to cater to the educational and administrative needs of the students and staff. College provides bus facilities for students with 50% consession on the routes

- 2. ICT enabled classrooms for Teaching- Learning.
- 3. 100Mbps leasedline Internet connection and Wi-Fi facility
- 4. The College has signed 13 MoU's.
